

Juice (fruit, vegetable and combination) sold as PART OF SCHOOL MEALS AND SEPARATELY FROM SCHOOL MEALS must comply with Section 10-221q of the Connecticut General Statutes (C.G.S), the U.S. Department of Agriculture (USDA) regulations for school meals and the USDA Smart Snacks nutrition standards for competitive foods. Juice must be pasteurized 100 percent full-strength juice (fresh, frozen or made from concentrate), and cannot contain added sugars, sweeteners or artificial sweeteners. These requirements apply to all public schools, regardless of whether the district implements Healthy Food Certification (HFC) under C.G.S. Section 10-215f.

The Food and Drug Administration (FDA) labeling regulations allow 100 percent juice to contain added ingredients, such as artificial flavors and colors, and still be labeled "100% juice." Connecticut's beverage statute follows the federal definition for 100 percent juice. Therefore, some juices on this list may contain added ingredients such as artificial flavors, artificial colors (e.g., red 40, blue 1, yellow 5 and 6, titanium dioxide), preservatives (e.g., sodium benzoate, potassium sorbate), flavor enhancers (e.g., ethyl maltol, salt) and emulsifiers/thickeners (e.g., glycerol esters of wood rosin, glyceryl abietate, ester gum, brominated vegetable oil, xanthan gum, guar gum, propylene glycol and modified food starch). The Connecticut State Department of Education (CSDE) encourages schools to choose 100 percent juices that do not contain these additional ingredients.

This list includes products that comply with STATE AND FEDERAL requirements. Product formulations and packaging can change. The nutrition information below is based on the package label or manufacturer information supplied at the time of product review. If this information does not match the product label, please submit the product's nutrition information to the CSDE.
