

## Lunch Menu Planning Checklist for Seven-day Week • Grades K-8

This checklist assists schools with planning meals to meet the U.S. Department of Agriculture's (USDA) meal pattern requirements for the National School Lunch Program (NSLP). Lunch	Yes	No <sup>1</sup>
Each meal includes all five components: meat/meat alternates, grains, fruits, vegetables, and milk.		
<b>Milk</b>	<b>Yes</b>	<b>No <sup>1</sup></b>
All milk offered is low-fat (1%) unflavored or fat-free unflavored or flavored.		
At least two different varieties of milk are offered.		
Whole and reduced fat (2%) milk are not served.		
<b>Fruits Component</b>	<b>Yes</b>	<b>No <sup>1</sup></b>
Each meal includes at least ½ cup of fruit. <sup>2</sup>		
The weekly menu includes at least 3 ½ cups of fruit. <sup>2</sup>		
If served, 100% fruit juice does not exceed half of the weekly fruits component, i.e., no more than 1 ¼ cups. (Indicate "N/A" if fruit juice is not served.)		
<b>Vegetables Component</b>	<b>Yes</b>	<b>No <sup>1</sup></b>
Each meal includes at least ¾ cup of vegetable <sup>2</sup>		
The weekly menu includes at least 5 ¼ cups of vegetables <sup>2</sup>		
The weekly menu meets all vegetable subgroups (5 ¼ cups total):		
<input type="checkbox"/> <b>Dark Green:</b> ½ cup dark offered weekly		
<input type="checkbox"/> <b>Red/Orange:</b> ¾ cup offered weekly		
<input type="checkbox"/> <b>Beans and Peas (Legumes):</b> ½ cup offered weekly		
<input type="checkbox"/> <b>Starchy:</b> ½ cup offered weekly		
<input type="checkbox"/> <b>Other:</b> ½ cup offered weekly (or dark green, red/orange, beans/peas, or starchy)		
<input type="checkbox"/> 2 ½ cup of additional vegetables offered weekly to reach 5 ¼ cups total (choose from any of the five vegetable subgroups)		
If served, 100% vegetable juice does not exceed half of the weekly vegetables component, i.e., no more than 2 ⅝ cups. (Indicate "N/A" if vegetable juice is not served.)		
Leafy greens such as romaine lettuce and fresh spinach are counted as only half of the actual portion size served, i.e., 1 cup of leafy greens equals ½ cup of vegetable.		
<b>Grains Component</b>	<b>Yes</b>	<b>No <sup>1</sup></b>
Each meal includes at least 1 ounce equivalent (oz eq) of grains.		
The weekly menu includes 11-12.5 oz eq of grains. <sup>2</sup>		
All grains are whole grain-rich. For more information, see <a href="#">Criteria for Whole Grain-rich Foods</a> .		
Grain-based desserts are limited to no more than 2 oz eq per week.		
<b>Meat/Meat Alternates (M/MA)Component</b>	<b>Yes</b>	<b>No <sup>1</sup></b>
Each meal includes at least 1 oz eq of M/MA.		
The weekly menu includes 11-14 oz eq of M/MA. <sup>2</sup>		

Offer versus Serve	Yes	No <sup>1</sup>
Students are required to select at least ½ cup of fruit or vegetable for a reimbursable meal.		
In addition to ½ cup of fruit or vegetable, students are required to select the full portion of at least two other components for a reimbursable meal.		
<b>Dietary Specifications (Nutrient Standards) for Weekly Menus <sup>3</sup></b> (Indicate "unknown" if you do not conduct your own nutrient analysis.)	<b>Yes</b>	<b>No <sup>1</sup></b>
Calories are within the allowable range of 600-650 calories.		
Saturated fat is less than 10% of total calories.		
Sodium does not exceed 1,230 milligrams. <i>This first sodium target is extended through June 30, 2018.</i>		
All nutrition labels and manufacturer specifications indicate zero grams of trans fat per serving.		

- <sup>1</sup> If "no" is checked for any of the statements above, the menu does not comply with the meal pattern requirements. Check the menu and revise accordingly.
- <sup>2</sup> Larger amounts of milk, fruits, vegetables, grains, and meat/meat alternates may be served only if meals do not exceed the weekly limit for calories, saturated fat, and sodium.
- <sup>3</sup> Schools are not required to conduct a nutrient analysis of menus. The CSDE will conduct a nutrient analysis as part of the state administrative review.
