

## **Bureau of Special Education Mediators**

**Patricia Auber** is a certified and licensed speech and language pathologist. She holds a B.A. from the University of Connecticut, an M.A. in speech pathology from Southern Connecticut State University and a Sixth Year degree in educational administration from the University of Hartford. She has 34 years of experience serving in public, private, and magnet school settings. In addition to her duties as a direct service provider, assistive technology consultant and supervisor, Patricia has presented on topics including special education progress monitoring, assistive technology, reading interventions for the speech pathologist, para-professional training, and inclusion practices for secondary students.

**Christine Barrington** received her B.A. and M.P.A. from the University of Rhode Island and her J.D. from the University of Massachusetts School of Law. After graduating, she practiced as a criminal defense attorney in Boston before relocating to Connecticut and opening a private general practice which included special appointments from both the Connecticut and Massachusetts Department of Education to ensure disabled children who are wards of the state have their educational rights protected. She also serves as the Director of the Paralegal Program at Branford Hall Career Institute. Additionally, Attorney Barrington volunteers as a Guardian Ad Litem for Children in Placement and has volunteered as a collaborating attorney with the New Britain Truancy Intervention Project and Lawyers for Children America. She also served on the RIPIN Advisory Board committee for USDOE PIRC Grand Administration.
